- No child shall be subjected to physical punishment or mental harassment.
- No child is required to pass any board examination till the completion of elementary education.
- d. Inclusion of students with disabilities/ special need as per provision of the (rule/ clause of State Act).
- e. The teachers are recruited with minimum qualifications as laid under (rule/ clause of the state Act).
- f. The teachers perform his duties specified under (rule/ clause of the state Act).
- The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
- No unrecognized classes shall run within the premises of the school or outside in the name of school.
